# 5 risk-reward ratios

The software is designed according to:

Risk-performance ratio "lowest risk (R1)": approx. 5% drawdown and 0.7% performance target per month – on equity (after all fees)

Risk-performance ratio "lower risk (R2)": approx. 10% drawdown and 1.0% performance target per month – on equity (after all fees)

Risk-performance ratio "medium risk (R3)": approx. 15% drawdown and 1.4% performance target per month – on equity (after all fees)

Risk-performance ratio "higher risk (R4)": approx. 30% drawdown and 2.1% performance target per month – on equity (after all fees)

Risk-performance ratio "maximum risk (R5)": approx. 45% drawdown and 2.7% performance target per month – on equity (after all fees)

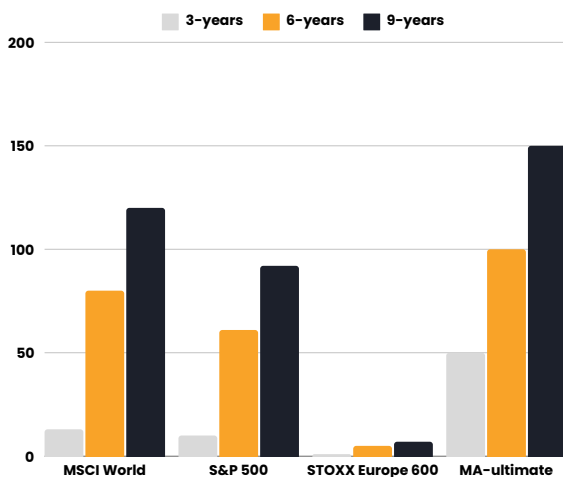




# Fees

A fair fee model was deliberately chosen because hardly any investor would be able or willing to bear even a portion of the more than 3,000 hours of development costs.

1. Strategies set up fee: 4.2% as a one-time payment; billing by Elyque FZCO ([www.elyque.com](http://www.elyque.com))
2. Strategies maintenance fee: monthly 0.35% of the account balance; will be automatically deducted by the broker (ACY)
3. Strategies usage fee: 3.5 USD each lot, for every entry that has been closed; will be automatically deducted by the broker (ACY)
4. Strategies success fee: monthly 35% of the positive performance after a so called high-water-mark has been reached; will be automatically deducted by the broker (ACY)
